### **Town of Argyle, Code of Ordinances, Section 3.02.002:**

It shall be unlawful for any person, firm or corporation to initiate building construction work, mechanical (heat and air) work, plumbing work, or electrical work within the Town of Argyle, without first having applied for and obtaining registration from the Town of Argyle. Said application shall require such information as the Town of Argyle may determine appropriate and proper with respect to the name, address, background, experience, and previous licensing of applicant.
