A Special Election is hereby ordered to be held on May 14, 2011 for the purpose of reauthorization of the local sales and use tax in the Town of Argyle Texas, Texas at the rate of one-quarter of one percent to continue providing revenue for maintenance and repair of municipal streets. This election is being conducted as a joint election with the Denton County Elections Department.
